Good afternoon, Victoria.

You had asked for our Executive Orders. Attached, please find the two that I have discovered and kept. There are 10 pages for one of them and one page for the second.

In addition, when Governor Minner disbanded the Department of Administrative Services (under which we fell) through Epilogue language in the Budget Bill in 2006, we were moved to Department of State, unbeknownst to us. There was a legal conflict with us being in that Department and our federal agents prompted me, the Governor's office, and the Secretary of State to move us to another agency that did not provide services to people with disabilities. We chose the Department of Safety and Homeland Security. Both of these moves occurred through the Epilogue language in the Budget Bill.

The DDC was first moved to the Department of State in FY 2006 as part of the budget (HB300) and then subsequently moved to Homeland Security in FY07 (SB 350). Below are links to both budgets.

I had asked at the time of the Controller General's Office and the Office of Management and Budget if we needed a new Executive Order and the response was negative.
